SUBJECT: Issuance of Revised Optional Forms OF-288 and OF-296

The General Services Administration (GSA) has issued revised versions of the Emergency Firefighter Time Report (OF-288) and the Vehicle/Heavy Equipment Pre-Use Inspection Checklist (OF-296). The revisions are intended to better meet current business requirements and are based on subject matter input. Please share this information with the pertinent individuals in your agency.

Significant changes to the OF-288 include:

- Removal of social security number and home mailing address
- Renaming of form to "Incident Time Report"
- Collection of hiring unit accounting code
- Landscape orientation to facilitate data entry requirements into other payment systems
- Available hardcopy of fillable download
- Expected to be available in the e-ISuite system for the 2016 fire season

Significant changes to the OF-296 include:

- Renaming of the form to "Vehicle/Heavy Equipment Pre-Use Inspection Form" (removes "safety" from the title and clarifies that the form is for pre-use)
- Removal of the "release inspection" columns
- Addition of Section III – Liability (operator acknowledges responsibility for the operation and condition of the equipment)
- Other minor changes to clarify inspection requirements consistent with current equipment in use
- Available hardcopy only.

Due to the lead time required to get the new forms printed through the General Services Administration (GSA), National Fire Equipment System finance kits (NFES 00390) and logistics kits (NFES 0910) will be updated as these kits undergo refurbishment from 2016 incident use.

Great Basin Incident Support Cache will be unable to fill unit orders until such time as their inventory is restocked with the new forms. Users should order from GSA to restock local unit supplies of these forms.

For the OF-288, please destroy all older versions. Use the electronic version until the hard copy is available.

For the OF-296, please begin replacing the old forms immediately. The old form cannot be used beginning October 1, 2016.
